- *Will Joint Basing be different this time?* There has been some discussion, but the problem is how to capture success or failure of Joint Basing in a BRAC
- *There is some dissatisfaction with Joint Basing, can it be unwound?* There is not much discussion around unwinding Joint Basing, the message the DOD is sending is that Joint Basing works.
- *Is there an update on projected Force Structure?* There is still uncertainty, but the army will announce this summer. The question is how much infrastructure is needed for the Force Structure.
- *Are local voices (e.g. through listening sessions) in this force structure process?* Yes. The army finds listening sessions very valuable.

##### WMA Partners Introductions/Updates

- Rich Hadley, GSI: New KC-49 Tankers, a future mission attempt. Water survival training mission moving from Florida to Spokane. Several encroachment issues.
- Steve Gerritson, EDC Seattle-King County: Just convened the 32<sup>nd</sup> annual meeting and published several reports. Working on strengthening the “Aerospace Kitsap Alliance”. Government counselling service led to \$60 million in contracts in the district.
- John Dogero, PNDC: Upcoming symposium may 27<sup>th</sup>-28<sup>th</sup>.
- Tiffany Scroggs, PTAC: Helping companies connect and contract increasing. Alliance Northwest went very well. Looking for opportunities to grow their footprint in Washington.
- COL Gent Welsh, WA Military Department: WA Youth Academy reaches 8,500 individuals. Upcoming Oso commemoration. The fire forecast is bleak this year. Looking ahead to sequestration this fall. Opportunities for improvement in accommodation for National Guard members.
- Alfie Alvarado-Ramos, WA DVA: Currently focused on legislative session. The transition council is very important. Recent transition event in Yakima was a success.
- Jim Baumgart, Governor’s Office: The operating budget will be released soon.
- Patrick Pierce, PSRC: Gave a shout out to the WMA for all it has accomplished.

## New Business

### **Legislative Session Update**

Government Budget Proviso, RE: Military Compatible Land Use Study. Commerce has been asked to do this. A person has been hired and a report should be available by November.

Rep. Parker Capital Budget Request for Fairchild. Kristine wrote a letter about this value. Opportunities like this are a good future value of the WMA

Jim Baumgart expressed the Governor's Office's support of growth of the WMA to respond to things like the capitol budget request.

Rich Hadley gave background on Fairchild Land Use Compatibility.

### **New OEA Grant Opportunities**

Trade and Export Grant—is there interest, could we help PNDC, how can we help industry pivot to export? Suzanne Dale-Estey and Tiffany Scroggs commented about clutter in Trade and Export assistance, and how this grant could fit in. John Powers sees the value of this opportunity and expressed his support. Rich Hadley thinks this is a really good example of something a 'grown up' WMA could do well. There was general consensus to continue with this opportunity. Kristine will create a group to continue looking at it.

Statewide Joint Land Use Study. There was general consensus to continue with this opportunity. Continued discussion will move to the Executive Leadership Team.

There is an opportunity for a Pacific Northwest ADC Event. There was general consensus that the WMA should put together a plan.
