Suggested Recommendations on Public Stance Issues

General Recommendations:

1. LAND USE/ENCROACHMENT/ENDANGERED SPECIES/NEGATIVE TRAINING IMPACTS
 - a. When proposals create the potential for negative impacts, articulate a letter of support advocating the military and economic value of the installation
 - b. Provide consistent public response to all public comment opportunities brought to the WMAs attention in support of military operations that will not infringe on the citizens right to: public safety, public privacy, or the health and welfare of the state.

2. FUTURE MISSIONS
 - a. Any opportunity to grow the capacity of the military in WA should be approached from a positive value-add and supported based on two criteria; 1. Does the local military advocacy organization want the mission at the installation? And 2. If a broader statewide mission capacity, does it provide for jobs and economic revenue that provide positive impacts for the community.

3. DEFENSE INDUSTRY IMPACTS
 - a. Focus on this via the Military & Defense Sector program in the department of commerce and the DOD OEA DIA grant.
 - b. Support WMA members like PTAC and PNDC recommendations for legislative action
